4.1 Description of first aid measures:

By inhalation:

Rinse eyes thoroughly with lukewarm water for at least 15 minutes. Do not allow the person affected to rub or close their eyes. If the injured person uses contact lenses, these should be removed unless they are stuck to the eyes, in which case this could cause further damage. In all cases, after cleaning, a doctor should be consulted as quickly as possible with the SDS of the product.

By ingestion/aspiration:

Request immediate medical assistance, showing the SDS of this product. Do not induce vomiting, because its expulsion from the stomach can be hazardous to the mucus of the main digestive tract, and also risk damage to the respiratory system through inhalation. 5.1 Extinguishing media:

Suitable extinguishing media:

Product is non-flammable under normal conditions of storage, manipulation and use, but the product contains flammable substances. Isolate leaks provided that there is no additional risk for the people performing this task. Evacuate the area and keep out those without protection. Above all prevent the formation of any vapour-air flammable mixtures, through either ventilation or the use of an inert medium. Destroy any source of ignition. 7.1 Precautions for safe handling:

A.- Precautions for safe manipulation
